# **CONDITIONS OF ENTRY**

# Acceptance of conditions

**1.** Information regarding prizes and how to enter forms part of these conditions. By entering, entrants accept these conditions.

## **Restrictions on entry**

(c) Tax Store partners shall be the one to register their clients in the Win a Car Promo Registration page [LINK], completely fill out online entry form, providing their client reference, full name, Tax return category, Store Visited, date visited, address, valid email address, valid email address, phone number and any additional information as required by the Promoter. #### Awarding prizes

**16.** The Promoter may require winners to provide proof of identity, proof of age, proof of a current and valid 'full' Australian driver's license and proof of residency at the nominated prize delivery address. Identification considered suitable for verification is at the Promoter's discretion.

#### **Disqualification of entries**
